

Journey Unauthorized - Hospitality/Travel



The following are the specific hospitality and travel accommodation requirements for the members of "Journey Unauthorized".

This performance rider will be agreed to by both parties and considered an addition to the contract attached for this performance to take place on _____, by and between Journey Unauthorized, hereinafter referred to as "PERFORMERS" and _____, hereinafter referred to as "PURCHASER".

Please initial next to each (applicable) item on the rider to show purchaser's approval and acceptance.

Air Travel: *Initial _____ • PURCHASER to provide five (5) round-trip tickets for PERFORMERS to the airport nearest the venue and to send the tickets, including full itinerary, to PERFORMERS no later than 30 days prior to date of engagement. For flights over 3 hours in length to venue location, PURCHASER is to ensure arrival for the PERFORMERS one night prior to date of engagement, and that hotel rooms are provided on the night of arrival (see Hotel Accommodations for more details).

PURCHASER may also opt to send to the Performers the total cost of air-fare (in US dollars) for five (5) round-trip tickets no later than 60 days prior to date of engagement.

International Travel: *Initial _____ • PURCHASER to provide any required visa's for international travel.

Ground Transportation: *Initial _____ • On engagements where PERFORMERS are being flown in, PURCHASER is to provide ground transportation for PERFORMERS from airport to hotel and/or venue. PURCHASER is to provide a small secondary vehicle to accommodate band equipment and PERFORMERS personal effects.

Hotel Accommodations: *Initial _____ • PURCHASER to provide five (5) separate rooms with a minimum three-star rating (AAA) within close proximity to venue. For travel times over 3 hours in duration from the PERFORMERS home location, PURCHASER to ensure that rooms are included for the night prior to the date of engagement, and throughout the entire duration of agreed engagement.

Meals and Refreshments: *Initial _____ • PURCHASER to provide one (1) meals per day **per member** for agreed engagement dates.

Backstage Dressing Room at Venue: *Initial _____ • PURCHASER to provide a secure backstage dressing room with ample lighting and mirrors, a restroom, and towels. PURCHASER also to provide soft drinks (Pepsi - regular *and* diet), one case of bottled water, coffee (including cream and sugar), a deli meat/veggie platter with breads, and a fresh fruit tray in PERFORMERS dressing room or backstage area for each date of agreed engagement.

Merchandise: *Initial _____ • PURCHASER to provide 1 8ft. table and 5 chairs with no arms or wheels, Audience Control tape to form a line at merch to be provided by the venue and to be ready by showtime, labeled 'Merchandise'. Also: Venue needs to provide electrical outlet in close proximity to merch table.
